

Sidney, Nebraska, July 24, 2018 A Fair Housing City

A meeting of the Mayor and Council of the City of Sidney, Nebraska, was convened in open and public session at 7:15 P.M. on July 24, 2018 in the Council Room. Present were: Mayor Arterburn and Council Members: Gallaway and Olsen. Absent: Gaston and Utley. Others present: City Manager Sadler, City Attorney Sonntag and City Clerk Anthony. Notice of the meeting was given in advance thereof by publication in *The Sidney Sun Telegraph*, the designated method for giving notice, a copy of the proof of publication being attached to these minutes. Advance notice of the meeting was also given to the members of the City Council and a copy of their acknowledgment of receipt of notice is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the City Council. All proceedings shown hereafter were taken while the convened meeting was open to the attendance of the public.

Mayor Arterburn informed the public of the location of the posted Open Meetings Act.

Olsen moved, Gallaway seconded "That Council Members Gaston and Utley be excused from this meeting." Roll call vote: All council members present. Absent: Gaston and Utley.

Gallaway moved, Olsen seconded "That the minutes of the July 10, 2018 be approved as printed." Roll call vote: Yeas: All council members present. Absent: Gaston and Utley.

Michael Namuth, Director of the Cheyenne County Community Center, appeared to present the Center's participation reports and the financial summary for this last year. Questions and answers pertaining to these reports was held.

Ronnie Meyer, Board Chairperson of the Sidney Airport Authority, presented the Authority's request for their 2018-19 Budget Tax Request. He also gave the Council a detailed report regarding the accomplishments for the last year and an excellent status report of their facility. The Council will consider the 2018-19 Budget Tax Request when the valuation numbers have been received from Cheyenne County.

Gallaway moved, Olsen seconded "That the June, 2018 Budget Reports for all departments be approved." Roll call vote: Yeas: All council members present. Absent: Gaston and Utley.

City Manager's/Staff Report: City Manager Sadler reported that the proposed budgets for FY2018-19 are in progress and that council workshops need to be scheduled (August 6-10 did not work – August 13-17-Council to get back to Ed). He also reported that the LB840 Northside project for sidewalks will be bid out soon. The Solid Waste bond issue has been placed as per Baird & Co. with a bank. Jarrod Konz has resigned from the Airport Authority so we will be advertising the vacancy.
